# **Guidelines for Authors**

**Abstract:** An abstract should be around 200 words inclusive of Objectives, Research Approach/Methodology, Findings and Conclusion with 5 key words. The full name, addresses and email addresses of all authors should be sent along with the abstract.

Manuscripts should be of up to 2,500 words (Font-Times New Roman ,Regular, Paper Size- A-4 , Line Space-1.5 , Title of the Paper- 16 point font, Heading- 14 point font and Body Content- 12 point font, Sub-Heading- 12 bold). Manuscripts must be submitted with the cover page bearing only the title of the paper and authors' names, designations, official addresses and phone/fax numbers. Only original, unpublished work is sought. Full paper must have an Abstract with 5 Key Words, followed by Introduction, Review of Literature, Research Objectives, Methodology, Data Analysis & Interpretations, Findings, Recommendations, Conclusion and References. Abstract and full paper must be sent as a Word Document as attachment to sibmtconference@suryadatta.edu.in

Any paper submitted to present identical or substantially similar work already published or under review for another

conference or publication will not be considered. The covering letter accompanying the manuscript, the contributor(s) should certify that the manuscript has neither been published any where nor is at present being considered anywhere for publication.

**End notes:** All notes should be indicated by serial numbers in the text and literature cited should be detailed under Notes at the end of the paper bearing corresponding numbers, before the references.

References: Arrange the reference list in alphabetical order of author's surnames, and chronologically for each author where more than one work by that author is cited. The author's surname is placed first, followed by initials, and then the year of publication is given followed by details of the publication. References should appear in the text as: "Apostolou et al. (2001) reported that ..." and the list of all the references must be placed at the end of the manuscript in Harvard Referencing Style (for example: Wharton, N. 1996. Health and safety in outdoor activity centres. Journal of Adventure Education and Outdoor Leadership, 12(4): 8-9.).

**Tables/ annexure:** It should be given after references. Figures can appear within the text.

**Declaration:** Author/s must declare the originality of their work. The paper should not have been published or submitted for publication elsewhere.

**Review Criteria:** All papers will be sent for double blind peer review. Based on comments of Reviews, convener of the Conference reserves the right to the final decision.

**Presentation:** All selected papers are to be presented formally by the authors. Each presentation would be restricted to 10 minutes, followed by question answer session for another 5 minutes. The article contributed by joint authors can be presented by any one of them.

In-Absentia: In-absentia, papers are accepted for publication if the author registers for the conference and paper meets earlier specified requirements.
