1. Other holidays in SPPU calendar are clubbed in the Diwali vacation.
2. Attendance is mandatory for all teaching and non-teaching staff at the flag hoisting ceremony on Independence Day and the flag unfurling ceremony on Republic Day. Non-attendance will be viewed seriously.
3. In view of statutory, regulatory, and university requirements, including but not limited to university and government compliances, internal and university examinations, NAAC, NBA, AICTE, SPPU, MSBTE, BATU, BCI, PCI, Boards, and other accreditation or regulatory activities, the institution reserves the right to adjust, reschedule, or defer holidays. Such adjusted holidays may be availed at a later date, subject to institutional approval.
4. No leave shall be granted to teaching and non-teaching staff on the days immediately preceding or following the above holidays, except with prior written approval of the competent authority, due to critical academic, administrative, and compliance-related obligations.
5. In case of unforeseen events, emergency situations, inspections, audits, or urgent directives from regulatory or statutory authorities, concerned staff members shall be required to report for duty, even on declared holidays. Compliance with such instructions shall be mandatory and treated as an official duty.
